Isabelle Lavoie, DRC reviewed the **status of Society motions** that were passed last year. Isabelle explained that the process includes having motions presented and passed at a CRC. The motions are then reviewed internally for regional motions and to have recommended actions brought forward to Society. The Society motions are brought forward at a Society Board meeting or at a Tech Council meeting. Society motions are discussed at a Regional Subcommittee of Members Council that Guy attends who would then present the motions, and defends, explains or provided additional information. The Subcommittee could then refer a motion to Tech Council, Publications, or internally for Members Council to review. A motion report is typically available on the Society web site in November.

#### 2. Review of CRC 2010 Motions

DRC Lavoie reviewed the **status of Society motions** from the 2010 CRC. They are follows:

#### London Chapter - Motion 8 (10/24/10):

That ASHRAE allow on-line web access to handbooks to full ASHRAE members in good standing through their ASHRAE membership fees at no extra charge.

Defeated because this would be a significant fiscal impact on Society.

# Ottawa Valley Chapter - Motion 9 (10/24/10):

That Society changes the date format on the Chapter Master List report form month/day/year to year/month/day.

Defeated because not all chapters will want this change on their reports; an action item was assigned to staff to provide instructions for the chapters' use.

# **Hamilton Chapter – Motion 10 (10/24/10):**

That the Society Honors and Awards Committee expand Category E "General Activities" criteria for the Distinguished Service Award and the associated Exceptional Service Award to include points for those ASHRAE Life Members serving on the Executive Board of the ASHRAE Life Members Club [LMC] with 1 point for a year's service as the Chair, 1 point per year's service as Secretary; ½ point per year as Vice-Chair; ½ point per year as Treasurer and ¼ point for each the of the other directors.

02/01/11 – Withdrawn. The H&A Committee recommends that points not be given for service on the Executive Board of the Life Members Club (LMC). The LMC Executive Board is not a recognized standing ASHRAE committee and its level of activity is not comparable with that of groups permitted service points on the ESA/DSA Point Tally Form.

# Hamilton Chapter – Motion 11 (10/24/10):

That the Society Honors and Awards Committee expand Category E "General Activities" criteria for the Distinguished Service Award and the associated Exceptional Service Award to include points for those ASHRAE members serving on the Executive of ASHRAE Research Canada [ARC] with 1 point for a year's service as the President, ½ point for a year's service as Secretary; and ¼ point for each of the other three Class "A" Directors.

02/01/11 – Withdrawn. The H&A Committee recommends that points not be given for ASHRAE Research Canada (ARC). The ARC's workload is not comparable to existing recognized groups permitted service points on the ESA/DSA Point Tally Form.

# Ottawa Valley Chapter – Motion 26 (02/01/11):

That the Society President-Elect update PAOE criteria and point values for History to encourage efforts focused on ensuring preservation and accessibility of chapter historical data.

02/01/11 - Approved.

# Ottawa Valley Chapter - 2010 Fall CRC:

#### **HISTORY**

George Menzies, RVC, reported the following:

- During the year 2010-11, all the chapters made the minimum points re PAOE, up from prior years.
- Five chapters exceeded PAR.
- However, six chapters had lower PAOE scores than for the year 2009-2010.
- There were no "Gold Ribbon" candidates from our Region for past year.
- We did have 2 winners in the prior year: Ottawa Valley and NB/PEI
- Effective July 2011, the qualifications to win a "Gold Ribbon" for updating a chapter's history is now somewhat more difficult [this is result of Region 2 Motion to require a 5 year update instead of one]. The Society HC considered this too difficult and reduced it to a 3 year cycle.
- However, there are many other ways to win the Gold Ribbon based on a single historical article re person, company; system; and a piece of equipment.

#### **Background Information:**

ADTBAT received a letter from the chapter earlier this month informing them of the chapter's intentions and the upcoming region II CRC plenary session where the motion would be submitted.

Initial considerations 5 years ago for forming a sub chapter in Abitibi region came from a nucleus of local industry related individuals that wished to organizes themselves to form an entity to promote building science knowledge and development. In the first stages it seemed as a good idea to be an ASHRAE sub chapter. With time and being the only organization in that remote territory their scope began to broaden to embrace today a very large spectrum of the building industry.

ADTBAT is now a vision like organization with an autonomous legal and financial operation, therefore not qualifying as a sub chapter as described in the chapters manual of operations. They manage their own finances and do not report to the Board of governors.

They have grown in a self-sustaining organization with a broader scope of interest, including: fire protection, plumbing, electricity and HVACR.

# **Motion No. S-3**, August 28<sup>th</sup> 2011 **Hamilton Chapter**

#### **Background Information:**

This standard will address two aspects of ASHRAE Strategic Plan approved by BOD March 20, 2006.

<u>Firstly</u>, air filtration is the primary means to protect occupants of buildings or other enclosures from potentially harmful effects of aerosols and particulate matter. **At present there is not a recognized test standard to evaluate the performance of an industrial oil mist collector.** Establishment of such a standard will address the strategic plan goal B2 (*Provide an optimal indoor environment for buildings and facilities with respect to comfort productivity, <u>health and safety</u>) because of the importance of air filtration to this overall goal. The existence of a uniform test method for oil mist collectors that is consistently reliable, repeatable and reproducible will allow the industry to properly select oil mist collectors for protection of building occupants.* 

<u>Secondly</u>, if the oil mist collector is significantly efficient to meet OSHA,NIOSH and other countries air quality requirement, the previously discarded air may be returned to the work area and reduce the overall energy requirements of the building. This will address ASHRAE's strategic goal A7 (Develop evaluation methods that allow reductions in energy, cost and emissions as well as improvement in comfort).

Application of Results: This new standard will permit designers, manufacturers and users of oil mist collector to measure and evaluate the performance of their devices according to an industry standard. This new standard can be used by users/purchasers to properly specify the level of protection required by building occupants as well as oil mist collector manufacturers to uniformly evaluate the performance of the collector.

Why is controlling oil mist so important? Metal working operations have long used liquid coolants to cool and lubricate parts to improve productivity and extend cutting tool service life. During metal machining, an airborne oil mist, is generated. These airborne contaminants are not only a nuisance but can also cause severe health problems to building occupants. Airborne exposures to the coolants have been implicated in health problems including irritation of the skin, lungs, eyes, nose and throat. Long term issues such as dermatitis, acne, asthma, hypersensitivity pneumonitis, irritation of the upper respiratory tract, and a variety of cancers have been associated with exposure to metal working fluids. These fluids are complex mixtures of oils, detergents, surfactants, biocides, lubricants, anti-corrosive agents, and other potentially toxic ingredients whose long term health effects are still being assessed.

# **Background Information:**

Several PAOE points are determined using Chapter reports available through Society. Many of these PAOE points are not directly shown in Chapter reports. The Chapter Officers & Committee Chairs must manipulate the data in different reports using sorting and/or filtering techniques in order to determine PAOE points. This process can be time-consuming and error-prone since data column headings in reports may be unclear and PAOE point's descriptions can be ambiguous to first-time Chapter Officers & Committee Chairs. Documentation that provides step-by-step instructions on how to determine each and every PAOE points from Chapter reports would be very beneficial. Instructions covering i) what Chapter report to use, ii) what column headings to analyze, iii) what data manipulation (if any) should be performed and iv) how to read the results would better ensure the accuracy and validity of all POAE recorded by a Chapter. These step-by-step instructions could be added to the training manuals distributed to Committee Chairs during CRC workshops.
