Society has a Canadian bank from which chapters receive the chapter dues, so a transaction in CAD funds to a Canadian institution seems feasible to us.

Fiscal Impact: Programming time to straight-up copy-paste the current donation page, but to link the back end with a transaction service that deals in Canadian Funds. Creation of a link on current page to the new page if someone selects ASHRAE Research Canada. 4-8 hours of work for ASHRAE staff?

During the MP planning meeting at CRC, we hypothesized that we should be able to define a set of metrics which can quantify and clearly communicate the value employers realize through employing ASHRAE members. It's also assumed that metrics will vary by employer category (manufacturer vs utility vs consultation firm). These metrics would be collected by interviewing employers who have a number of employees.

Hypothetical Examples: ASHRAE members are 20% less prone to making errors, 10% more productive, produce 5% more revenue, have 15% more quality connections to decisionmakers, have 6-month reduced onboarding time, etc

Background Information: "Challenge Accepted: Tackling the Climate Crisis" is this year's ASHRAE theme, which is bold and beautiful, but is mostly related to sustainability and decarbonization. In 2023, Halifax has been battered by climate related disasters – fires in the spring, and floods in the summer. The change in weather patterns will significantly impact how buildings need to be designed, built, and maintained. ASHRAE has already been working on resiliency standards (241) and guidelines (wildfires) at the Society level, and this initiative would be a great catalyst to apply that work to the real world. In addition, we believe that this would resonate with younger generations who are anxious about the future; these projects could encourage younger engineers to pursue innovative solutions which can have a positive impact in their community.

For Annual meetings, the host city typically has a demonstration project that the ASHRAE community supports. This motion is along the same idea, but with implementation at the CRC.

Fiscal Impact: Impact depends on the project chosen, and level of community support.

Motion: To create a regional working group which works across all chapter committees to identify common gaps in chapter digital infrastructure and processes, explores possible solutions, and then produces a report outlining integrated opportunities to increase efficiency for all critical chapter functionalities.

Background Information: Most Chapters suffer from deficiencies and inefficiencies regarding their web presence (website, social media) and digital tools - which stems from volunteer turnover, a lack of experience, and a lack of process in managing these digital assets. All chapters are allocating efforts to address these issues, but often within silos, and with varying degrees of success. Moreover, the continuous rotation and churn of volunteers mean that improvement initiatives may be restarted every year – or abandoned.

Basecamp is an example of a tool provided and implemented by Society to help in the passing on of historical information from year-to-year, which includes communication and calendaring tools. However, there are still implementation gaps, and Basecamp does not address all the digital needs of chapters.

Fiscal Impact: Small investment to explore solutions to determine viability (purchasing software tools or licenses beyond "demo" functionality to test them out. The time and efficiency gains by volunteers by improving tools and processes is in the 10s of thousands of dollars for our region alone
